## OFFICE ORDER

- 1. The eligibility of an officer for University accommodation shall be determined as per the Grade Pay of such Officer in his present post held in the University or its constituent units.
- 2. Date or priority in respect of lower type accommodation i.e. Type-1 to Type-IV shall be the date of joining the service in the University.
- 3. The inter-se seniority for the higher type accommodation shall be considered on the basis of following principles, namely;
  - (i) Firstly the Grade Pay of the officer.
  - (ii) Secondly the priority dates within the same Grade Pay. In this case the priority date shall be date from which the applicant continuously drawing his existing Grade Pay.
  - (iii) Where the priority date of two or more officers in the same, the inter-se seniority of the officers shall be determined on the basis of the basic pay i.e. the officer who have a higher pay shall be senior in the waiting list.
  - (iv) Where the priority date and the basic pay of two or more officers are the same, the earlier date of joining in the service of the University shall be the next determining principle of inter-se seniority, and
  - (v) Where the priority date, basis pay and the date of joining in the service of the University of two or more officers are the same, the officers retiring earlier may be accorded higher priority over the officer retiring letter.
- 4. The Estate Officer will inform the Chairman House Allotment Committee about vacant position of quarters on 1<sup>st</sup> day of January, March, May, July, September and November every year.
- 5. The Chairman, House Allotment Committee will notify these vacancies and invite applications. These new applications shall be disposed of in the next four weeks and allotment orders shall be issued so that the quarters are occupied in next two weeks.
- 6. Since there is variation in quality of quarters, in one category, the employees should give his preference of quarter sub category in that category. The allotment will be done by seniority basis of that preferential sub-category.





7. The allottee shall maintain peace in the premises. Report of any kind of indiscipline in maintaining peace liable to vacation of quarters.

Other terms and condition for allotment of quarters shall remain the same as notified in Regulation for Allotment of Residential Accommodation. 1994 till a new Regulation is framed and notified by the University.
