#### A. Terms and Conditions

Sealed tenders are invited by the Controlling Officer, DBT Project and Director Research, RPCAU, Pusa (Samastipur), Bihar for supply of sixty adult Black Bengal female goats under "Establishment of Biotech-Kisan hub in Aspirational districts of Bihar" at RPCAU, Pusa, Samastipur, Bihar

- 1. The bid must contain details of goats to be supplied.
- 2. Rates quoted should be F.O.R. RPCAU, Pusa. Samastipur, Bihar, inclusive of all taxes and charges. The rates must include loading, forwarding, transit, and insurance charges. The same should be insured against death of goat, theft, loss or injury during transit by the supplier before dispatch is made. The responsibility in this respect will be of the supplying firm and not of the University.
- 3. Supply of the goat is acceptable on bill basis only.
- 4. Payment shall be made within 30 days from the date of receipt of goats in satisfactory conditions i.e. delivery of healthy live goats.
- 5. The payment will be made through RTGS/ NEFT. The firm must mention their account details i.e. name of account holder, account number, name of the bank with address, branch code, IFS Code etc.
- 6. Tender documents must be submitted consisting of NIT/ Tender form, terms and conditions of supply, special conditions, if any. Schedule of quantities filled, completed and signed by tenderer).
- 7. Authorized dealers/ Authorized supplier must submit authorization certificate.
- 8. Tender should be addressed to the Controlling Officer, DBT project and Director Research, RPCAU, Pusa, Samastipur, Bihar 848125.
- 9. The Earnest Money Deposit (EMD) for goat in the form of D.D. from Nationalized Bank should be Rs. 10,000/- drawn in favour of Controlling Officer, DBT project and Director Research, RPCAU, Pusa payable at Punjab National Bank, RPCAU, Pusa. Any tender without proper EMD shall not be considered and will be rejected solely on this ground.

- 10. The tender so submitted shall be governed by the GFR 2005. In terms of GFR 2005, tenderers may face legal action, if they amend tender, impair or derogates from the tender in any respect within the period of validity of this tender.
- 11. The supplier will have to attach a certificate to the effect that the goats to be supplied will be of the same standards specified.
- 12. The taxes which are not quoted in tender by the supplier will not be paid by the University under any circumstances.
- 13. The terms and conditions given by the supplier will not be binding upon the University. Rejection of conditional tenders shall be the sole discretion of the competent authority of the University.
- 14. The date/ period of delivery of equipment must be clearly mentioned in the bid document as applicable.
- 15. In cases of any dispute arising out in process of tender finalization, the matter shall be referred to the sole arbitrator who in such case will be the Vice Chancellor of RPCAU, Pusa and whose verdict shall be final and binding on both the parties.
- 16. The tenderer may be called for technical discussion by the tender committee duly constituted or nominated by the competent authority of this University.
- 17. The acceptance of tender will rest with the University who does not bind itself to accept the lowest tender and reserves itself as the authority to reject or partially accept, any or all the tenders received without assigning any reason.
- 18. The University reserves the right to place order for the scheduled quantity and or part thereof.
- 19. Tenders are likely to be rejected in case it does not confirm to the specifications, terms and conditions etc. as laid down in tender document.
