- b. Selected applicants shall have to substantiate their claim through submission of original documentary proof, prior to their joining, in case of any discrepancy found either before or after the appointment, the appointment shall be cancelled/terminated forthwith without assigning any reason thereof.
- c. Applicants must ensure that the documents/enclosures submitted are correct and that they meet the minimum eligibility requirements, failing which they may not be allowed to appear for interaction (Interview) with the Selection Committee; and
