
**URGENT NOTICE**

In this connection, the UG students of II Sem. (2020-24), V Sem. (2019-23), VII Sem. (2018-22), IX Sem. (2017-21) and XI Sem. (2016-20) are hereby advised that when you arrive at University campus, you must come with the completion of vaccination dose (both 1<sup>st</sup> and 2<sup>nd</sup>) alongwith the Vaccination Certificate and/ or single does certificate plus RT-PCR report (72 hours). It is mandatory to show and deposit to the authorities of the University. Failing with, and not producing the Vaccination Certificate (Antigen or RTPCR test) you will not be allowed to stay in the Hostel and also to sit in the class rooms for lectures.

Accordingly, you all Under-Graduate students of II Sem. (2020-24), V Sem. (2019-23), VII Sem. (2018-22), IX Sem. (2017-21) and XI Sem. (2016-20) requested to attend physical offline classes at RPCAU, Pusa from **15<sup>th</sup> November, 2021** following the guidelines as mentioned above for general welfare of our RPCAU family, in which you also belongs, for the better health status of the Campus.
