EXPRESSION OF INTEREST

Invitation for Expression for Interest for setting up Community Radio Station at Dr. Rajendra Prasad Central Agricultural University, Pusa for their educational, developmental, social and cultural needs.

Background:

Dr. Rajendra Prasad Central Agricultural University, Pusa, Samastipur has been established under the Central Government Act for teaching, research and extension in the field of agriculture and allied subjects. The University has the mission to promote high-quality learning and creation of integrated approach that develops an appreciation and understanding of the socio-economic and environmental significance of soil-plant-animal-people interface.

The University is imparting regular education at Bachelor, Master, and Doctorate level for various agriculture and allied sciences and carrying on extension services for farming and allied areas to help improve the farm yields.
