- (ii) An Alumna/Alumnus shall automatically become eligible for member of the Association on payment of the appropriate Membership fees as per Clause 8 (c) of the bylaws.
- (d) Student Member- Any student/scholar who pays the subscription fees of Rs. 200/- at the time of admission can be considered as student member. He/she shall be automatically became member of the association after passing out from the college.

#### TERMINATION OR CESSATION OF MEMBERSHIP:
