The same can be extended in one (01) year basis on candidate's every one year performance assessment and fund availability.

Shortlisted candidates will be intimated through E-mail and would bring their complete bio-data/curriculum vitae with one photograph and duly self-attested certificates and mark sheets (From Class X onwards) along with original certificates in support of qualification, age and copy Master Thesis, experience certificate and no objection certificate from their current employer at the time of interview.
