It should be clearly remembered this post is purely temporary and co-terminus with the project and the continuance of the above post will be strictly subject to financial support from Bihar 4th Krishi Road map vide letter No. रा. खा. सु. मि. को. 45/2023 पी. पी. संख. 43/कृ., पटना dated: 02/08/2023. Engagement will depend upon the review of year-to-year performance of the candidate or as deemed fit by the Competent Authority.
