It should be clearly remembered this post is purely temporary and co-terminus with the project and the continuance of the above post will be strictly subject to financial support from ICAR-AICRP (Fruits). Engagement will depend upon the review of year-to-year performance of the candidate or as deemed fit by the Competent Authority.
4. Further, this post is governed strictly by the relevant rules/regulations/conditions of service framed under the project “**National Surveillance Programme for Aquatic Animal Diseases (NSPAAD)-Phase-II**” and the RPCAU, Pusa from time to time.
